## TERMS OF REFERENCE

#### Project Aim:

The DISCOVER project will create a new service to deliver digital skills training; this will focus in particular on opportunities for informal carers, as a socially excluded group, but also target formal carers and the older people who are being cared for. Based on existing eLearning systems in Birmingham and Thessaloniki, the DISCOVER platform will integrate the existing systems and provide access to rich digital skills learning experiences.

#### Project Objectives:

- Increased digital competences and engagement of social inclusion actors (carers).
- Increased use of ICT solutions for enabling social support and care.
- Improved recognition and appreciation of the importance of Social Care work

#### **Activities**

The primary role of the DISCOVER Project Advisory Board is to act as a critical friend and assist, in an advisory capacity, in the development of a successful project.

Therefore the DISCOVER Project Advisory Board will:

- represent and solicit intelligence and feedback from Carers and other key stakeholders;
- advise on content / products developed by the DISCOVER project;
- guide the DISCOVER development where there are changes to the provision for carers e.g. legislative, training and support provisions;
- advise and guide on content relevance to the care sector and
- provide knowledge and intelligence on care provision and training.



Members of the Project Advisory Board should reflect and represent each DISCOVER partner locality and key stakeholders of the DISCOVER project e.g. local policy makers, care providers, carer organisations, organisations for the elderly, training providers, accreditation bodies, care givers, etc. thereby increasing buy-in.

Members will:

- 1. Guide the development of DISCOVER as an agreed pathway for digital skills learning and raising carers' aspirations.
- 2. Act as Ambassadors for DISCOVER especially within Local Government, the Care, Learning and Training sectors.
- 3. Engage with carers in order to validate the DISCOVER programme.
- 4. Act as a source of guidance and expertise in relation to the specific aspects of the DISCOVER Programme and to influence development by identifying connections and synergies with other initiatives.
- 5. Advise on the development of a mission statement that builds on the DISCOVER statement "Digital Inclusion Skills for Carers bringing Opportunities, Value and Excellence" e,g. "innovative ways of doing things differently in a digital world".
- 6. As a stakeholder, support the dissemination of the DISCOVER project and products, utilising their influence to expand DISCOVER by promotion to relevant companies / agencies; and the identification of events, forums and activities (current and future) where DISCOVER could be promoted.
- 7. Take part in occasional (e.g. 6-monthly) Web/Telephone Conferences to facilitate project activities.

## Size and Composition

The Project Advisory Board will have representatives from each partner locality (local or national) that represent the key stakeholders of DISCOVER, a minimum of 2 up to a maximum of 5 representatives per country (UK, NL, ES, GR & IRE). Representatives will be nominated by the Consortium Partners and appointed by the Project Steering Group with consent of all partners.
